The GST Council in its meeting dated 10th March 2018, had recommended the introduction of e-way bill for inter-State movement of goods across the country from 1st April 2018. For intra-State movement of goods, e-way bill system will be introduced w.e.f. a date to be announced in a phased manner but not later than 1st June, 2018.

With the press release dated April 10, 2018, the GST Council had informed about intra-state e-way bill has been implemented in the States of Andhra Pradesh, Gujarat, Kerala, Telangana and Uttar Pradesh & Karnataka from 15<sup>th</sup> April, 2018.

With the press release dated April 18, 2018, the GST Council has informed that e-Way Bill system for intra-State movement of goods would be implemented in the States of Bihar, Jharkhand, Haryana, Himachal Pradesh, Tripura & Uttarakhand.

#### **Details of E-Way Bill implementation system for intra state movement of goods:**

SL.NO	STATE	DATE OF IMPLEMENTATION
1	Bihar	20th April, 2018
2	Jharkhand	20th April, 2018
3	Haryana	20th April, 2018
4	Himachal Pradesh	20th April, 2018
5	Tripura	20th April, 2018
6	Uttarakhand	20th April, 2018

With the implementation of intra state e-way bills in the above states, it is expected that trade & industry shall have a positive impact as far as transportation is concerned.

Inter-state movement of goods already under the purview of e-way bill & with intra state movement of goods slowly but steadily coming under its umbrella, a nation-wide single e-Way Bill system may soon be in motion.

The government has advised Trade and industry and transporters located in these States to obtain registration/ enrolment on e-Way Bill portal namely <https://www.ewaybillgst.gov.in> at the earliest without waiting for the last date.
